FACTS

FACTS, or Families Acting for Community Traffic Safety.

FACTS gives students an opportunity to better understand, and even teach traffic safety! Students will use 3 essential topics, including; **People**; to understand and promote your role as a driver or passenger and keep yourself and others safe. **Vehicles**; to understand vehicle safety and the role it plays in safety for you and others. And finally, **Roads**; to understand and promote your role on the road as well as the safety hazards you may encounter and how to avoid or react to them.

Participants will use these 3 topics to educate themselves and their community about traffic safety, and enforcing local laws and regulations.
