YOUR STATE PRESIDENT!

As we start working on our STAR events, it is important to look at the rubrics to ensure that we score the highest amount of points as possible! When preparing for your STAR event make sure that your presentation or demonstration follows the order of the content on the rubric. For example if the first category on the rubric for your event is Relationship to Family and Consumer Sciences, then you should first focus on the relationship to family and consumer sciences so that evaluators will be less likely to miss information. Another important tip to getting full points on the rubric is using key words that are in the rubric. For example, if one of the criteria is including a SMART goal, then when talking about your goal you should make sure to describe the SMART acronym:

- specific,
- measurable,
- achievable,
- relevant,
- time bound.

Competing in STAR events can sometimes be daunting, but just make sure to **follow** along with the rubric to ensure your success!
